General Terms and Conditions

General Provisions

The seminar/conference contents correspond to the descriptions in the seminar brochure and the broadcasts. Any changes or additions to the contents will be communicated to the participants at the latest at the beginning of the seminar / conference.

The seminar or conference documents used are protected by copyright and may not be reproduced (including extracts) without the consent of the Austrian Imago Association (IGÖ) and the respective speaker or be used commercially.

IGÖ is entitled to make changes to the seminar prospectus regarding the course of the seminar, the maximum number of participants, the place and period of the seminar, provided that there is an important reason for doing so and the legitimate interests of the participants are no longer negligibly impaired. Lecturers can be replaced at any time by others who are equally or better qualified, especially if they become ill.

Unless you expressly object to this in writing, the copyright for photographs taken during the seminar / conference will go to IGÖ.

Registration

A binding registration for the conference has to be sent by email to office@imagoaustria.at or by registering online at www.imagocongress.at.

The respective early bird bonus can only be claimed if you register by the given date. For workshops with a maximum number of participants, registration is only possible until the limit has been reached.

Terms of Payment

The prices quoted are fixed prices.

The payment period is 14 days from receipt of the payment request, which we will send you by e-mail.

In the event of late payment or exceeding of the payment period, the time-limited discount (early bird discount) applicable at the time of registration can no longer be claimed and the participant must pay the price listed in the price table at the time of payment!

If at the latest 14 days before the start of the seminar or meeting there is no or insufficient payment or proof of payment, the participant cannot attend the conference or seminar and will not receive a certificate of attendance.

The claim for payment from IGÖ nevertheless remains valid in this case.

Cancellation

In case of a written deregistration of the conference up to 12 weeks before the start of the conference, a cancellation fee of Euro 50, - will be kept by IGÖ. Cancellation after this is associated with a cancellation fee of 100% of the conference fee, unless a suitable replacement participant can be named, then only the cancellation fee of € 50 will be charged (see above). The deregistration requires the written notification by mail or e-mail.

Each participant is entitled to name a suitable substitute participant for the conference offer at any time, for which he or she - for any reason whatsoever - cannot attend. This is possible until the day of the beginning of the event. A substitute participant is especially suitable if he / she has the necessary previous knowledge and fits in the target group of the conference. Regardless of this, IGÖ reserves the right, in individual cases, to reject a substitute participant.

ATTENTION: The deregistration or cancellation of a hotel reservation already made by you as a participant in the conference hotel is subject to the applicable cancellation conditions of the booked conference hotel regardless of these terms and conditions and may incur additional cancellation costs.

Right of Withdrawal

If the seminar is booked as a private person, the participant has a legal right of withdrawal within 14 calendar days from the conclusion of the contract. This does not apply to events that already begin within these 14 calendar days from the conclusion of the contract.

The resignation period is considered to be respected if the resignation is sent within the deadline. Withdrawals from the contract declaration are therefore possible within 14 calendar days from the conclusion of the contract without stating reasons by sending a written declaration of withdrawal (eg letter, fax, e-mail). It is sufficient if the resignation is sent within this period (the date of the postal order is decisive). Saturdays do not count as working days.
